**Agriculture** — "The time has not passed for developing countries and LDCs to get a permanent solution on public stockholding, without which they should not go home. Such a solution should be better than the Bali Peace Clause."

"We, as an NGO that defends the rights of small-scale producers of the Global South, are appalled that agri-exporters are blocking the negotiations on agriculture. On a food security perspective, this is dramatic. Once again, the WTO proves to be inefficient to defend the voices of the Global South and to allow more policy space for member countries for granting protesting farmers' demands."

**Fish** — "India should not agree to a fisheries agreement on OCOF disciplines unless it can get a 25-year extension period and full exemptions on small scale fishers. The agreement will permanently seal my fate and the fate of my fellow fishers – all 100 million of them. There is no rush to sign an agreement."

**E-commerce** — "I am glad that India, South Africa, Indonesia, and others are standing firm in opposing the unnecessary and onerous e-commerce moratorium. There is no need for such a moratorium when countries are still working out their optimal tax mix for the digital economy, and when so much digital economic value

flows across borders. I hope other countries join, and even the EU must rethink its support for the moratorium given its quest for AI sovereignty. No country can stand to indefinitely lose one way of taxing the digital economy. Various studies have shown that the VAT is a poor substitute for customs duties when several policy objectives need to be met." – Jai Vipra, Researcher, IT for Change, India – contact information redacted from this online version

"Getting rid of the tax holiday for Big Tech - ie the moratorium on customs duties on e- transmissions - is one of the most important achievements for working people around the world that MC13 could achieve. This would allow countries to strategically use trade policy to deploy digital industrialization policies for job creation and structural transformation."


